Land Arrangements, Services/Taxes and Cancellations

INCLUDED: Air Transportation from Chicago or New York via **EI Al Israel Airlines**. Transfers, Hotel, Breakfast and Dinner daily, Touring, Entrance fees, Tips, Taxes (subject to change).
